	(122.971) and to enact new section 122.98 and
	section 122.981 of the Revised Code to create the
	Ohio Aerospace and Defense Advisory Council.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 122.98 (122.971) be amended for the	6
purpose of adopting a new section number as indicated in	7
parentheses, and new section 122.98 and section 122.981 of the	8
Revised Code be enacted to read as follows:	9

Sec. 122.98 122.971. (A) The Ohio steel industry advisory	10
council shall do all of the following:	11
(1) Conduct an examination of existing federal and Ohio laws	12
which currently affect the production and consumption of Ohio	13
steel, problems which the Ohio steel industry currently faces,	14
including foreign competition and the economic climate for the	15
Ohio steel industry, and other matters relevant to the future of	16
the steel industry in this state;	17
(2) Submit an annual report, no later than the first day of	18
October of each year, to the speaker and minority leader of the	19
house of representatives, the president and minority leader of the	20
senate, and the chairpersons of the standing committees of the	21

house of representatives and senate to which matters concerning commerce and labor are normally referred. The report shall propose methods to expand the use of Ohio steel within the state, the United States, and the world; identify problems facing the Ohio steel industry discovered during the council's activities; and make recommendations to modify state statutes or rules.

- (3) Upon request, advise state and local government officials on questions and matters affecting the steel industry;
 - (4) Work closely with the Ohio steel futures program.
- (B) The director of development shall transmit copies of all requests for information and assistance from the steel futures program and copies of program evaluations conducted by that program to the council. The council may make recommendations to the steel futures program regarding research and development and funding of programs to be undertaken by the steel futures program.
- Sec. 122.98. (A)(1) There is hereby created the Ohio aerospace and defense advisory council, which shall consist of eleven voting members and not more than six nonvoting members.

(2) The governor shall appoint the eleven voting members of the council with the advice and consent of the senate, and shall designate one of these members to serve as the chairperson of the council. The voting members so appointed by the governor shall be individuals who are knowledgeable in at least one of the following fields: aerospace technology, national defense issues associated with aerospace technology, issues facing private enterprises that conduct business in the aerospace industry, technology commercialization, or other fields that are relevant to the mission of the council as determined by the governor.

The governor shall make the appointments of the voting members so that they represent, as determined by the governor, designated geographical regions of the state in the following manner: not less than two voting members shall represent the Cleveland metropolitan region; not less than two voting members shall represent the Miami valley region; and any remaining voting members shall represent all other regions of the state. All of the voting members so appointed by the governor shall be employees or former employees of private enterprises, except that not less than two of the voting members shall be faculty members of a public or private institution of higher education associated with aerospace technology matters.

Not more than six of the voting members so appointed by the governor shall be members of the same political party.

(3) The governor also may appoint two additional members of the council with the advice and consent of the senate if the governor considers additional members to be necessary. These additional members shall be nonvoting members. One of the additional members shall be an employee of the United States air force who is assigned to the Wright-Patterson air force base. The other additional member shall be an employee of the national aeronautics and space administration who is assigned to the John

(4) The president of the senate shall appoint to the council	73
two members of the senate, each of whom shall be a member of a	74
different political party. The speaker of the house of	75
representatives shall appoint to the council two members of the	76
house of representatives, each of whom shall be a member of a	77
different political party. These legislative members shall serve	78
as nonvoting members of the council.	79
(B) The terms of office of the council's members appointed by	80
the governor shall be three years from the date of appointment.	81
The terms of office of the council's legislative members shall be	82
for the biennial session of the general assembly in which they are	83
appointed. Vacancies shall be filled in the same manner as	84
provided for original appointments. Members may be reappointed.	85
(C) The council shall meet at least once each six months or	86
more frequently upon the call of the chairperson or upon the	87
