A BILL

To amend sections 1545.09 and 1545.99 of the Revised

Code to provide increased penalties for violations
of a bylaw or rule adopted by a board of park
commissioners of a park district in a county and
to permit a board of park commissioners to adopt
penalties for any such violation provided the
penalties do not exceed in severity the penalty
designated by state law for a similar violation
under state law.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:
