Sec. 3321.30. (A) As used in this section, "parent" means	7
either of the natural or adoptive parents of a student, except	8
under the following conditions:	9
(1) When the marriage of the natural or adoptive parents of	10
the student has been terminated by a divorce, dissolution of	11
marriage, or annulment or the natural or adoptive parents of the	12
student are living separate and apart under a legal separation	13
decree and the court has issued an order allocating the parental	14
rights and responsibilities with respect to the student, "parent"	15

(B) This section applies to any city, exempted village, or	32
local school district in each school year in which the school	33
district ratings published under section 3302.03 of the Revised	34
Code after the first day of July of that school year declare the	35
district to be in need of continuous improvement, under an	36
academic watch, or in a state of academic emergency.	37
(C) The parent of each student enrolled in a school district	38
to which this section applies shall attend, prior to the	39
thirty-first day of December of the school year, at least one	40
parent-teacher conference held by the school the student attends	41
to meet the student's teachers. The conference shall provide an	42
opportunity for the parent and the student's teachers to establish	43
expectations of the student for the school year, discuss the	44
student's performance at school, and foster effective	45
communication. In the case of a parent who has more than one child	46
enrolled in the district, the requirement of this division shall	47
apply separately with respect to each of the parent's children so	48

(E) The board shall notify parents of students enrolled in	63

(F) The board shall adopt a policy establishing procedures by	67
which a parent may appeal the fine imposed under division (D) of	68
this section. The policy shall require the board to waive the fine	69
for any parent who shows good cause as to why the parent was	70
unable to comply with division (C) of this section.	71
(G) The board shall use all fines collected under this	72
section solely to pay the costs of establishing and operating	73
mentoring programs for students or other volunteer programs.	74
