## A BILL

To enact section 5501.70 of the Revised Code to 1 require the Director of Transportation to 2 designate portions of state highways, county or 3 township roads, or streets or highways located within municipal corporations as memorial highways 5 in honor of each State Highway Patrol trooper, 6 county sheriff, deputy sheriff, township constable, or police officer of a township police 8 department or district or law enforcement agency 9 of a municipal corporation who is or has been 10 killed in the line of duty. 11

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:
