## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4503.526 of the Revised Code be ..... 3
enacted to read as follows:Sec. 4503.526. (A) The owner or lessee of any passenger car,5
noncommercial motor vehicle, recreational vehicle, or other ..... 6
vehicle of a class approved by the registrar of motor vehicles may ..... 7
apply to the registrar for the registration of the vehicle and ..... 8
issuance of "Ohio Statehouse" license plates. The application for ..... 9
"Ohio Statehouse" license plates may be combined with a request ..... 10
for a special reserved license plate under section 4503.40 or ..... 11
4503.42 of the Revised Code. Upon receipt of the completed ..... 12
application and compliance with division (B) of this section, the ..... 13
registrar shall issue to the applicant the appropriate vehicle ..... 14
registration and a set of "Ohio Statehouse" license plates with a ..... 15
validation sticker or a validation sticker alone when required by ..... 16
section 4503.191 of the Revised Code. In addition to the letters ..... 17
and numbers ordinarily inscribed thereon, "Ohio Statehouse" ..... 18
license plates shall be inscribed with words and markings selected ..... 19
and designed by the capitol square review and advisory board and ..... 20
approved by the registrar. "Ohio Statehouse" license plates shall ..... 21
bear county identification stickers that identify the county of ..... 22
registration by name or number. ..... 23
(B) "Ohio Statehouse" license plates and validation stickers ..... 24
shall be issued upon payment of the regular license tax as ..... 25
prescribed under section 4503.04 of the Revised Code, any ..... 26
applicable motor vehicle tax levied under Chapter 4504. of the ..... 27
Revised Code, a bureau of motor vehicles administrative fee of ten ..... 28
dollars, the contribution specified in division (C) (1) of this ..... 29
section, and compliance with all other applicable laws relating to ..... 30
the registration of motor vehicles. If the application for "Ohio ..... 31
Statehouse" license plates is combined with a request for a ..... 32
