# INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 55**-Representatives Hagan, McGregor, Schaffer, Collier, Setzer, Wagner, Perry, Chandler.

To amend sections 1547.11, 4511.19, 4511.191, and 4511.197 of the Revised Code to reduce the prohibited concentrations of alcohol in a person's blood, breath, or urine for purposes of the OMVI Law, Implied Consent Law, and Watercraft Law, and to amend the versions of sections 1547.11 and 4511.19 of the Revised Code that are scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

**H. B. No. 56**-Representatives Callender, Seitz, Gibbs, T. Patton, Chandler, Miller, Carano, Schaffer, D. Evans, Hughes, Allen, D. Stewart, Otterman, Grendell, Ujvagi, Perry, S. Patton, G. Smith, Seaver, DeBose.

To enact sections 4501.551, 4503.551, and 4503.82 of the Revised Code to create Rock and Roll Hall of Fame license plates and to permit the creation of additional varieties of a nonstandard license plate at the rate of one variety for

every 20,000 motor vehicle registrations involving the original nonstandard license plate and its varieties.

# **H. B. No. 57**-Representatives Callender, Olman, Widener, T. Patton, Harwood.

To amend sections 1739.05, 1751.01, 3923.51, 4732.01, 4732.09, 4732.10, 4732.13, 4732.14, 4732.141, 4732.15, 4732.17, 4732.19, 4732.20, 4732.21, 4732.22, 4732.23, 4732.24, 4757.41, and 4757.42, to enact new section 3923.28 and sections 3923.281 and 4732.131, and to repeal sections 3923.28, 3923.29, and 3923.30 of the Revised Code to prohibit discrimination in health care policies, contracts, and agreements in the coverage provided for the diagnosis, care, and treatment of mental illness, and to permit the State Board of Psychology to license psychological associates.

# H. B. No. 58-Representative Kilbane.

To direct the General Assembly in its deliberations regarding the enactment of reforms of the state's tax laws.

**H. B. No. 59**-Representatives Kearns, Willamowski, Husted, D. Evans, Latta, Redfern, Ujvagi, Hartnett, J. Stewart, Schaffer, Carano, Seaver, Young, Harwood, Seitz.

To enact section 5533.69 of the Revised Code to designate a portion of state route number four within Clark County as the "Heritage Parkway."

# H. B. No. 60-Representatives Kearns, Koziura, Price.

To amend sections 3704.14 and 3704.99 and to enact section 3704.20 of the Revised Code to require anyone who sells or offers for sale a used motor vehicle to a person who resides in a county that is subject to the motor vehicle inspection and maintenance program to first have the vehicle inspected by an inspection contractor, to require the seller to have necessary repairs performed in order for the vehicle to pass the inspection and to provide the inspection certificate obtained for the vehicle to the purchaser of the vehicle, and to provide for a refund to the purchaser if the seller fails to have the vehicle inspected and provide the inspection certificate.

# H. B. No. 61-Representatives Kearns, Hagan, Widener.

To amend section 3734.35 of the Revised Code to apply to private sanitary landfills certain arbitration procedures related to the siting or modification of landfills, and to change the definition of "affected community" in the law related to those arbitration procedures.

Said bills were considered the first time.

REPORT OF THE SPECIAL COMMITTEE TO PURCHASE REVISED CODES, PURSUANT TO H. R. NO. 10, 125TH GENERAL ASSEMBLY.

The Special Committee to Purchase Revised Codes reports back with the following recommendations:

- 1. Given the availability of the Ohio Revised Code as a public resource on the Internet, this service shall be the default resource for members and staff. As needed to supplement this service, the Chief Administrative Officer is authorized to purchase and make available shared sets of the Revised Code, in hard bound form, as authorized in intem two below.
- 2. The West Group, which publishes Baldwin's Ohio Revised Code, shall be the primary vendor for supplying the value-added version of the Ohio Revised Code to the Ohio House of Representatives during the 125th General Assembly. The Chief Administrative Officer shall purchase sufficient copies of Baldwin's Ohio Revised Code, not to exceed ten copies, as provided below for the use of members, staff or offices of the House in accordance with Banks-Baldwin's proposal of February 12, 2003, with such additional modifications as may be agreed to between Banks-Baldwin and the Chief Administrative Officer. The Chief Administrative Officer shall also purchase an additional 100 copies of the printed index to be distributed to each member and the Clerk's Office.
- 3. The Chief Administrative Officer with the approval of the Speaker, may purchase additional sets of the Baldwin's Ohio Revised Code and/or supplemental service, replacement units, and legislative bulletins for the committee rooms and offices of the House of Representatives, including shared sets for members and their staff who are using the default service Internet version of the Ohio Revised Code.
- 4. The Public version of the Administrative Code shall be the default resource for members appointed to the Joint Committee on Agency Rule Review (JCARR). As needed to supplement this resource, the Chief Administrative Officer is authorized to purchase and make accessible to JCARR members and staff a value-added version of the Ohio Administrative Code. However, copies of the Administrative Code remain the property of the House.
- 5. All sets of the Ohio Revised Code, supplements, replacement units and legislative bulletins and all sets of the Ohio Administrative Code, including supplement service and replacement units shall remain the property of the House and shall be assigned to the member's office during that member's term.

To amend sections 5104.01, 5104.04, 5104.30, 5104.32, 5104.34, 5104.35, 5104.38, 5104.39, 5139.41, 5739.031, 5739.032, 5739.12, 5739.122, 5739.21, 5741.03, 5741.12, and 5741.121 and to enact sections 107.31, 107.32, 5101.31, and 5104.382 of the Revised Code to make program and budgetary modifications, to establish provisions regarding the possible closing of state institutional facilities for the purpose of expenditure reductions or budget cuts, to amend the versions of sections 5739.031, 5739.12, and 5741.12 of the Revised Code that are scheduled to take effect July 1, 2003, to continue the provisions of this act on and after that effective date, to amend Section 125 of Am. Sub. H.B. 94 of the 124th General Assembly, as subsequently amended, to amend Section 142 of Am. Sub. H.B. 94 of the 124th General Assembly, and to make an appropriation.
