# INTRODUCTION OF BILLS

The following bills were introduced:

To amend section 315.18 of the Revised Code to replace the mandatory duty of a county engineer to survey lands sold for taxes with discretionary authority to do so.

specification, to impose a three-year mandatory prison term for a conviction of aggravated vehicular homicide and a specification of three OMVI-related violations, and to amend the versions of sections 2903.06, 2903.08, 2929.01, 2929.13, and 2929.14 of the Revised Code that are scheduled to take effect on January 1, 2004, to continue the provisions of this act on and after that effective date.
