# INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 73**-Representatives Carano, Hartnett, Hoops, Young, Cirelli, Hollister, J. Stewart, McGregor, Boccieri, Grendell, Callender, Ujvagi, Allen, Seitz, Sferra, Kearns, Perry.

To amend sections 2744.02 and 4511.76 of the Revised Code to provide a full defense to liability under the motor vehicle exception to qualified sovereign immunity for a public school in cases involving negligent operation of a privately-owned motor vehicle that is not a school bus and to prohibit the Department of Education from regulating the use of certain privately-owned motor vehicles for student transportation, and to amend the version of section 4511.76 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

# H. B. No. 74-Representative DeWine.

To amend sections 3319.22, 3319.23, and 3319.26 and to enact sections 3319.228 and 3319.261 of the Revised Code to limit the provision requiring a delayed effective date for educator licensing rules to only those rules that require curriculum changes in teacher preparation programs and for amendment or rescission of such rules, to clarify that an Alternative Educator License be issued to an applicant upon the request of specified school officials, to prescribe the timing of the subject area provisional licensing examination required for individuals employed as intervention specialists under Alternative Educator Licenses, and to provide a qualified immunity for teacher performance assessment entities in civil actions concerning the conduct of teacher performance assessments of candidates for Professional Educator Licenses.

To amend section 3313.616 of the Revised Code to grant high school diplomas to veterans of the Korean Conflict and to expand eligibility for diplomas to certain non-resident veterans who attended Ohio high schools.
