## INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 412**-Representatives Jerse, D. Evans, Skindell, Hartnett, Olman, Distel, Hughes, Redfern, Ujvagi, Beatty, Perry, Schaffer, Latta, Strahorn, Seitz, Oelslager, Reidelbach, Allen, Williams, Carano, Cirelli.

To amend Section 31 of Am. Sub. H.B. 95 of the 125th General Assembly and to make a supplemental appropriation for the Adjutant General in fiscal year 2004.

**H. B. No. 413**-Representatives Peterson, Wolpert, Allen, Hollister, Aslanides, Setzer, Schaffer, Trakas.

To amend sections 1345.20, 4905.381, 4905.57, and 4905.73 and to enact sections 122.065, 122.066, 122.067, 122.068, and 122.069 of the Revised Code to establish the Community Technology Center Grant Program in the Department of Development.

**H. B. No. 414**-Representatives Core, Wolpert, Setzer, Jerse, Allen, Ujvagi, Webster.

To amend section 5709.85 and to enact sections 931.01 to 931.09, 931.99, and 5709.28 of the Revised Code to provide for the establishment of agricultural security areas, to limit development within those areas, and to provide the opportunity for certain tax exemptions for land within those areas.

Said bills were considered the first time.

I am directed to inform the House of Representatives that the Senate has concurred in the passage of the following bill:

**Sub. H. B. No. 388 -** Representatives Latta, Kearns, Willamowski, Hughes, Calvert, D. Evans, Flowers, Grendell. Senator Harris

To enact section 2503.45 of the Revised Code to authorize the Supreme Court to create a board, commission, or other entity to operate and maintain the facilities and attendant exterior grounds of the state-owned real estate located in Franklin County that this act conveys, to exempt that real estate from taxation and assessments, to authorize the conveyance of that real estate to the Supreme Court, and to declare an emergency.
