## TWENTY-FOURTH DAY

The House met pursuant to adjournment.

Pursuant to House Rule No. 21, the Clerk called the House to order.

Representative Collier was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 107**-Representatives Schneider, Cates.

To amend sections 3704.14, 4503.102, 4503.103, and 4503.11 and to enact section 4501.026 of the Revised Code to require the Registrar of Motor Vehicles to adopt rules permitting the owners of certain vehicles to register their vehicles on a biennial basis, to require the Registrar and all deputy registrars to accept credit cards for transactions with the Registrar or deputy, and to amend the versions of sections 4503.102 and 4503.11 of the Revised Code that are scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

**H. B. No. 108**-Representatives Driehaus, Seitz, Redfern, Kearns, Hartnett, Skindell, Niehaus, Distel, Olman, Yates, S. Smith, Schneider, DePiero, Webster, Allen, DeBose, Harwood, Barrett, Raussen, Perry, Cirelli, Raga, Jerse, Domenick, Wilson, Hagan, Mason.

To amend section 169.03 of the Revised Code to require that notice of unclaimed funds be mailed to owners by holders of the funds either by regular or certified mail depending upon the value of the funds and to authorize charges for certain mailings of notices.

**H. B. No. 109**-Representatives Schaffer, Young, Faber, Brinkman, Grendell, Fessler, Webster, D. Evans, Widowfield, Reinhard, Schmidt.

To enact section 718.17 of the Revised Code to require municipal corporations with more than \$100 million in annual income tax collections to provide a tax credit to nonresident taxpayers.

**H. B. No. 110**-Representative Driehaus.

To enact sections 101.91, 101.92, and 101.921 to 101.927 of the Revised Code to provide for appraisal of the effectiveness of tax expenditures and for

their expiration after appraisal if not renewed.

**H. B. No. 111**-Representative Boccieri.

To amend section 121.22 and to enact section 101.17 of the Revised Code to permit members of public bodies who are called to active duty, under specified circumstances, to vote from their active duty locations within twenty-four hours after a vote of the public body, to amend Section 5 of Sub. H.B. 390 of the 124th General Assembly to extend the time within which members of the National Guard and reserve components of the Armed Forces of the United States who have been called to active duty must pay real property and manufactured home taxes, and to declare an emergency.

Said bills were considered the first time.

**RE: COUNTY BUILDING CODES - PROTECT DRAINAGE**

Representative Hollister moved to amend the title as follows:

Representative Domenick moved to amend as follows:

In line 12, after "dwelling" insert "or any structure that is regulated by the Ohio building code".

Representative Wagner moved to amend as follows:

In line 7, delete "section" and insert "sections"; after "307.37" insert "and 711.131"

Between lines 144 and 145, insert:

"**Sec. 711.131.** Notwithstanding sections 711.001 to 711.13 of the Revised Code, a proposed division of a parcel of land along an existing public street, not involving the opening, widening, or extension of any street or road, and involving no more than five lots after the original tract has been completely subdivided,

may be submitted to the authority having approving jurisdiction of plats under section 711.05, 711.09, or 711.10 of the Revised Code for approval without plat. If the authority acting through a properly designated representative is satisfied that the proposed division is not contrary to applicable platting, subdividing, zoning, or access management regulations or regulations adopted under division (B)(3) of section 307.37 of the Revised Code regarding existing surface or subsurface drainage, it shall within seven working days after submission approve the proposed division and, on presentation of a conveyance of the parcel, shall stamp the conveyance "approved by (planning authority); no plat required" and have it signed by its clerk, secretary, or other official as may be designated by it. The planning authority may require the submission of a sketch and other information that is pertinent to its determination under this section."

In line 145, delete the first "section" and insert "sections"; after "307.37" insert "and 711.131"

In line 1 of the title, delete the first "section" and insert "sections"; after "307.37" insert "and 711.131"

The motion was agreed to and the bill so amended.
