*WHEREAS, The members of the House of Representatives of the 125th General Assembly of Ohio were deeply saddened to learn of the death of Arthur H. Milner and extend our heartfelt condolences to his family and friends; and*

*WHEREAS, Arthur Milner left an indelible impression on the people whose lives he touched, and he will be remembered as a spirited individual who contributed immeasurably to the world around him. A dairy farmer, he worked as a superintendent, principal, teacher, and coach with various school districts in Highland, Ross, Fayette, and Clinton counties. He was a member of the Ohio House of Representatives from 1950 to 1958 and vice chairman of its education committee, where he was responsible for the inception of the Ohio State Board of Education. In addition, he served as the first president of the Highland County Fair and Retired Teachers Association, commissioner of the Ohio Exposition Commission, member of the Highland County Farm Bureau, and a Sunday school teacher at Leesburg Friends Church; and*

*WHEREAS, Arthur Milner's regard for improving the quality of life in our society was clearly evident in his personal sacrifices of time and effort to his family, friends, and community, and he will be remembered for his generosity, talents, and seemingly inexhaustible energy. He displayed exceptional concern and insight in all of his endeavors, and his absence will be keenly felt; and*

*WHEREAS, A devoted husband to his wife, the late Helen, a loving father to his three children, Virginia, Arthur, and Marcia, and the proud grandfather of nine grandchildren and eight great-grandchildren, Arthur Milner always used his talents to the benefit of others, and the warmth and understanding he readily extended to those around him will stand as a testament to his personal character. Although the void his death has created can never be filled, the legacy of care and commitment he established will surely live on; therefore be it*

**"Sec. 4115.04.** (A) Every public authority authorized to contract for or construct with its own forces a public improvement, before advertising for bids or undertaking such construction with its own forces, shall have the director of commerce determine the prevailing rates of wages of mechanics and laborers in accordance with section 4115.05 of the Revised Code for the class of work called for by the public improvement, in the locality where the work is to be performed. Such schedule of wages shall be attached to and made part of the specifications for the work, and shall be printed on the bidding blanks where the work is done by contract. A copy of the bidding blank shall be filed with the director before such contract is awarded. A minimum rate of wages for common laborers, on work coming under the jurisdiction of the department of transportation, shall be fixed in each county of the state by said department of transportation, in accordance with section 4115.05 of the Revised Code.

(B) Sections 4115.03 to 4115.16 of the Revised Code do not apply to:

(1) Public improvements in any case where the federal government or any of its agencies furnishes by loan or grant all or any part of the funds used in constructing such improvements, provided the federal government or any of its agencies prescribes predetermined minimum wages to be paid to mechanics and laborers employed in the construction of such improvements;

(2) A participant in a work activity, developmental activity, or an alternative work activity under sections 5107.40 to 5107.69 of the Revised Code when a public authority directly uses the labor of the participant to construct a public improvement if the participant is not engaged in paid employment or subsidized employment pursuant to the activity;

(3) Public improvements undertaken by, or under contract for, the board of education of any school district or the governing board of any educational service center;

(4) Public improvements undertaken by, or under contract for, a county hospital operated pursuant to Chapter 339. of the Revised Code if none of the funds used in constructing the improvements are the proceeds of bonds or other obligations which are secured by the full faith and credit of the state, the county, a township, or a municipal corporation and none of the funds used in constructing the improvements, including funds used to repay any amounts borrowed to construct the improvements, are funds that have been appropriated for that purpose by the board of county commissioners, the state, a township, or a municipal corporation from funds generated by the levy of a tax; provided, however, that a county hospital may elect to apply sections 4115.03 to 4115.16 of the Revised Code to a public improvement undertaken by, or under contract for, the county hospital;

(5) Capital projects that are paid for in whole or in part with state funds."
