INTRODUCTION OF BILLS

The following bills were introduced:

To amend sections 3119.60, 3119.61, 3119.68, 3119.74, and 3119.79 and to enact sections 3119.77 and 3119.771 of the Revised Code to provide for the modification of a child support order at the request of a member of the uniformed services called to emergency military service.

H. B. No. 150-Representatives Fessler, Callender, Webster, Gilb, Reinhard, Reidelbach, McGregor, Jolivette.

To amend sections 2901.01, 2903.13, 2907.03, 2907.08, 2917.31, 2923.122, 2925.01, 3301.07, 3301.071, 3301.0722, 3301.16, 3313.671, 3313.94, 3319.22, 3319.32, 3327.01, 3332.02, 3333.21, 3333.37, 3365.01, 3781.11, 4117.10, 4732.15, 4732.22, 4743.03, 4757.41, 5104.01, and 5107.62 and to enact section 3301.0723 of the Revised Code to modify the powers of the State Board of Education, and to amend the versions of sections 2923.122 and 2925.01 of the Revised Code that are scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

To amend section 1306.20 and to enact sections 1306.25, 1306.26, 1306.27, 1306.28, and 1306.29 of the Revised Code to adopt the Electronic Government Services Act to prohibit a government agency from providing duplicative or competing electronic commerce services with the private sector, other than described cable service, unless the government agency complies with procedures established by the Act.

To enact section 4301.253 of the Revised Code to require the Liquor Control Commission, when considering enforcement actions against the holder of a permit authorizing the sale of beer or intoxicating liquor for consumption on the premises, to take into consideration whether the permit holder and the permit holder's employees have successfully completed a training program on specified topics.

To amend sections 703.21 and 1905.01, and to enact section 703.201 of the Revised Code to permit the dissolution of a village under certain conditions, to limit mayors courts to municipal corporations with a population of over 100 persons, and to amend the version of section 1905.01 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.
