**INTRODUCTION OF BILLS**

The following bills were introduced:

To amend sections 109.572, 173.41, 2151.414, 2151.419, 2151.86, 2152.74, 2152.81, 2901.07, 2905.05, 2907.06, 2907.27, 2907.28, 2907.30, 2921.38, 2929.13, 2935.03, 2937.11, 2945.481, 2945.49, 2950.01, 3301.32, 3301.541, 3313.662, 3319.39, 3701.881, 3712.09, 3721.121, 3722.151, 5103.0319, 5104.012, 5104.013, 5104.09, 5123.081, 5126.28, and 5153.111 of the Revised Code to expand "harassment by an inmate" to apply to all persons and rename the expanded offense "harassment with a bodily substance"; to designate the expanded offense a sexually oriented offense when the offense involves semen; to include the expanded offense when it involves semen within the laws dealing with criminal records checks for certain applicants, placement of children with parents who commit certain offenses, DNA specimens of offenders, child victim testimony, criminal child enticement and sexual imposition penalties, venereal disease and HIV testing of offenders, communicable disease notification of certain victims, prison terms for certain fifth degree felonies, warrantless arrests, permanent exclusion from public school attendance, and foster caregivers' notice of a child being found delinquent; and to amend the versions of sections 2929.13, 2935.03, and

2950.01 of the Revised Code that are scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

**H. B. No. 154**-Representative Redfern.

To amend section 4303.181 of the Revised Code to reduce from 100,000 to 20,000 the minimum population of a municipal corporation required for issuance of a D-5j liquor permit to a premises located within a community entertainment district located in that municipal corporation.

**H. B. No. 155**-Representative Brinkman.

To amend sections 9.81, 4113.02, 4117.03, 4117.05, 4117.09, and 4117.11; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 4113.02 (4119.04); and to enact sections 4117.031, 4117.081, 4119.01, 4119.02, 4119.03, 4119.05, 4119.06, 4119.07, and 4119.99 of the Revised Code to remove any requirement under the Public Employees Collective Bargaining Law that public employees join or pay dues to any employee organization, to expand the scope of unfair labor practices under that law, to make other changes in the Public Employees Collective Bargaining Law, to prohibit any requirement that employees of private employers join or pay dues to any employee organization and to require public and private employers to post notices to that effect, to prohibit certain actions by private employers relative to employee organization membership, and to establish civil and criminal penalties against private employers who violate those prohibitions.

WHEREAS, A loving husband to his wife, Jean, a devoted father to his two sons, Steve and Tom, and the proud grandfather of four grandchildren, Archer Reilly always used his talents to the benefit of others, and the laurels of his life stand as a tribute not only to him, but also to those he left behind. Although the void which his death has created can never be filled, the legacy of care and commitment which he established will surely live on. The world is a richer place for his having been in it, and he will be truly missed; therefore be it
