The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 156**-Representatives Willamowski, Setzer, Clancy, D. Evans, Fessler, Olman, DeWine, McGregor, Aslanides, Seitz, Brinkman, DePiero, Barrett, Seaver, Hagan, Hoops, Jolivette, Carmichael, Hollister, Schaffer, Allen, S. Patton, Faber, Blasdel, Distel, Kearns, S. Smith.

To amend sections 2305.234, 3701.262, 4715.02, 4715.03, 4715.12, 4715.13, 4715.14, 4715.16, 4715.23, and 4715.39, to enact new sections 4715.10 and 4715.11 and sections 3702.85 to 3702.95, and to repeal sections 4715.10, 4715.11, and 4715.15 of the Revised Code to make changes to the State Dental Board, to establish the dentist loan repayment program, and to make other changes to the laws governing dentistry in Ohio and to amend the version of section 2305.234 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

To enact sections 4501.501 and 4503.501 of the Revised Code to create 4-H license plates and the 4-H License Plate Fund and to provide that money in the fund be used to pay for the educational activities of the 4-H Youth Development Program of the Ohio State University Extension Program.

To amend sections 2925.01, 2925.02, 2925.03, 2925.04, 2925.36, and 2925.37 of the Revised Code to increase the penalties for certain controlled substance and drug offenses committed within a federally recognized "weed and seed site" and to amend the versions of sections 2925.01, 2925.02, 2925.03, 2925.04, 2925.36, and 2925.37 of the Revised Code that are scheduled to take effect January 1, 2004, to continue the provisions of this act

on and after that effective date.
