The House met pursuant to adjournment.

Pursuant to House Rule No. 21, the Clerk called the House to order.

Representative G. Smith was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 456-Representatives C. Evans, Schmidt.

To establish a community college district comprised of the territory of Lawrence County, to require the Ohio Board of Regents under certain conditions to issue a charter for a new community college operated jointly with the Collins Career Center in that district, and to create a partnership between the Collins Career Center and institutions of higher education through which the institutions offer courses at the career center.

H. B. No. 457-Representatives Olman, Seitz, Willamowski, Schaffer, Husted, Widener, Collier, Wolpert, Seaver, Kearns.

To enact section 3318.60 of the Revised Code to permit the Ohio School Facilities Commission to enter into agreements with school districts that have not received state assistance for classroom facilities under which the districts will receive payments in lieu of participating in other state programs for classroom facilities assistance.

H. B. No. 458-Representative Grendell.

To amend sections 1327.50, 5728.06, 5735.23, 5735.29, 5735.291, and 5735.292 and to enact section 319.56 of the Revised Code to delay for one year the increase in the motor fuel tax that is scheduled to begin taking effect in fiscal year 2005, to authorize county auditors to establish a motor fuel quality testing program, and to create the Gasoline Practices Oversight Commission for the period ending December 31, 2005.

H. B. No. 459-Representatives Trakas, Oelslager, Slaby, D. Stewart, Allen, Perry, Yates.

To enact sections 9.661, 125.25, 125.26, 1349.03, 1349.04, 1349.05, and 4113.24 of the Revised Code to establish restrictions related to work

performed outside the United States or by noncitizens with regard to state contracts, economic development assistance, employment termination notices, telephone and internet sales, and consumer financial information.

Said bills were considered the first time.
