INTRODUCTION OF BILLS

H. B. No. 462-Representative J. Stewart.

To amend section 1531.06 of the Revised Code to establish requirements governing the issuance of permits by the Chief of the Division of Wildlife in the Department of Natural Resources for the administration of contraceptive chemicals to noncaptive wild animals.

H. B. No. 463-Representatives Combs, Clancy, Young, Hollister, Collier, Flowers, Schneider, Schaffer, Wolpert, Hagan, Hughes, McGregor, Gibbs, Daniels, Walcher, Schmidt, Wilson, Jerse, Carano, Seaver.

To amend sections 3313.671 and 3701.13 of the Revised Code to require students to be immunized against chicken pox subject to certain exceptions.

Said bills were considered the first time.
