The House met pursuant to adjournment.

The journal of yesterday was read and approved.

### INTRODUCTION OF BILLS

The following bill was introduced:

H. B. No. 471-Representatives Flowers, Combs, Aslanides, Seitz, Webster.

To amend sections 9.36, 109.71, 109.73, 109.751, 109.77, 109.801, 313.05, 313.10, 325.17, 2901.01, 2935.01, 3705.16, 3705.29, 3705.99, and 4731.053 and to enact section 313.123 of the Revised Code to exempt certain coroner records from being public records, to designate coroner investigators as law enforcement officers for purposes of the Revised Code and as peace officers for purposes of receiving training at approved peace officer training schools and for certain other purposes, to require the State Medical Board to allow, in certain rules, a coroner's investigator who is not a physician to recite facts permitting a physician to pronounce a person dead without personal examination, and to make other changes to the Coroner's Law and associated provisions of the Death and Fetal Death Certificate Law.

Said bill was considered the first time.
