INTRODUCTION OF BILLS

To amend section 3354.121 of the Revised Code to eliminate the prohibition against the issuance of obligations by community college districts and state community college districts for the acquisition, construction, maintenance, or operation of housing and dining facilities.

H. B. No. 198-Representative Willamowski.

To amend sections 145.01, 145.33, and 145.49 of the Revised Code to create special provisions in the Public Employees Retirement System for public safety officials.

H. B. No. 199-Representative Willamowski.

To amend section 6137.03 of the Revised Code to require a hearing to be held prior to the levying of certain assessments for the maintenance of ditches.

H. B. No. 200-Representative Willamowski.

To enact section 3125.141 of the Revised Code to allow a child support enforcement agency to contract with a private person or entity to provide service of process or to compensate a sheriff for successful service of process.

To amend sections 3301.079, 3301.0710, 3301.0711, 3301.0712, 3301.0714, 3301.0715, 3301.91, 3302.01, 3302.03, 3302.04, 3313.532, 3313.6012, 3313.61, 3313.611, 3313.612, 3313.97, 3314.012, 3314.03, and 3317.012; to enact new section 3302.02 and sections 3302.021 and 3313.971; and to repeal sections 3301.0713, 3302.02, and 3365.15 of the Revised Code to comply with the "No Child Left Behind Act of 2001" by revising the system of statewide achievement testing to include annual achievement tests in reading and math in grades three through eight; requiring the State Board of Education to designate at least four ranges of scores on the Ohio Graduation Tests; changing the names of the levels of achievement associated with the achievement tests; requiring an annual determination of a district's progress toward meeting a "nationally proficient" level of achievement (AYP); prohibiting exemptions from taking achievement tests for limited English proficient students; making the administration of diagnostic assessments to certain students voluntary; specifying the state performance indicators for school districts and buildings; adding calculations of a performance index score to determinations of school district and building performance ratings; directing the Department of Education to incorporate a value-added progress dimension into the district and building report cards by July 1, 2005; creating the Ohio Accountability Committee to monitor the implementation of the value-added factor and to make recommendations regarding the state's accountability system; requiring the disaggregation of student performance data according to disability, limited English proficient status, and migrant status and eliminating disaggregations of data by vocational education status; specifying the sanctions for school districts and buildings, including community schools, that fail to meet performance standards; directing school districts to allow students enrolled in persistently dangerous schools to transfer; to amend the version of section 3313.608 of the Revised Code that is

scheduled to take effect July 1, 2003, to continue the provisions of this act on and after that effective date, and to declare an emergency, was taken up for consideration the third time.

Sub. H. B. No. 5-Representatives Walcher, D. Evans, Grendell, Gilb, Willamowski, Collier, Seitz, Latta, Faber.

To amend sections 1923.01, 1923.02, 2152.82, 2152.83, 2152.84, 2152.85, 2929.13, 2929.19, 2929.21, 2950.01, 2950.02, 2950.03, 2950.04, 2950.05, 2950.06, 2950.07, 2950.08, 2950.081, 2950.09, 2950.10, 2950.11, 2950.12, 2950.13, 2950.99, 5321.01, and 5321.03 and to enact sections 2950.031, 2950.111, and 5321.051 of the Revised Code to modify the Sex Offender Registration and Notification Law by adopting most of the recommendations of the Governor's Sex Offender Registration and Notification Task Force, generally conforming the Law to federal guidelines, providing a penalty for failing to send a notice of intent to reside, clarifying that habitual sex offenders in another jurisdiction are habitual sex offenders under Ohio law, clarifying the Law's community notification provisions as applied to multi-resident buildings, prohibiting a person convicted of a sexually oriented offense from establishing a residence within 1000 feet of any school premises, permitting landlords to evict from residential premises located within 1000 feet of school premises any person on the state registry of sexual offenders, specifying that convictions in courts of foreign nations are sexually oriented offenses under the Law, and making other changes in that Law, and to amend the versions of sections 2929.13 and 2929.19 of the Revised Code that are scheduled to take effect on January 1, 2004, to continue the provisions of this

act on and after that effective date, was taken up for consideration the third time.
