The House met pursuant to adjournment.

**INTRODUCTION OF BILLS**

The following bill was introduced:

**H. B. No. 201**-Representatives Schmidt, Wolpert, Seitz, Allen, Schneider, Raussen, Grendell, Hoops.

To amend sections 1345.81, 4501.25, 4738.01, 4738.03, and 4738.99, to enact new section 4738.18, and to repeal section 4738.18 of the Revised Code to allow licensed salvage motor vehicle auctions or pools to sell salvage motor vehicles only to specified authorized purchasers, to eliminate a buyer's identification card as a prerequisite for buying a salvage motor vehicle from a salvage motor vehicle auction or pool, and to amend the version of section 4501.25 of the Revised Code that is scheduled to take effect January 1, 2004, to continue the provisions of this act on and after that effective date.

Said bill was considered the first time.

#### Message from the Senate

Mr. Speaker:

I am directed to inform the House of Representatives that the Senate has passed the following bills in which the concurrence of the House is requested.

**Sub. S. B. No. 1** - Senators Amstutz, Fingerhut, Spada, Dann, Herington, Armbruster, Austria, Carey, DiDonato, Goodman, Harris, Jacobson, Mumper, Stivers, Robert Gardner, White.

To amend sections 122.151, 122.152, 122.154, 166.01, 166.02, 166.08, 166.11, 166.13, 166.14, 166.16, 5733.98, and 5747.98 and to enact sections 166.17 to 166.21, 184.04, 5733.352, and 5747.331 of the Revised Code and to amend Sections 41 and 41.15 of Am. Sub. H.B. 94 of the 124th General Assembly, as subsequently amended, to increase the dollar amount that may be invested in technology and revise the eligibility requirements for, and increase the maximum amount of, technology investment tax credits that may be issued; to create the Ohio Research Commercialization Grant Program; to increase the maximum amount of obligations that may be issued to fund economic development programs; to move the Innovation Ohio Loan Fund into the State Treasury; to create the Research and Development Loan Fund, and authorize the Director to make loans from that Fund and issue obligations for research and development projects; to grant tax credits for qualified research and development loan payments; and to make an appropriation.

**Sub. S. B. No. 67** - Senators Mumper, Wachtmann, Randy Gardner, DiDonato, Coughlin, Stivers, Austria, Goodman, Carnes, Carey, Schuring, Armbruster, Harris, Jacobson, Spada, White, Amstutz.

To amend section 901.99 and to enact section 901.511 of the Revised Code to prohibit damaging or destroying crops, timber, livestock, or equipment.
