INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 516-Representatives Seitz, McGregor.

To amend sections 123.01, 317.08, 3734.22, 3734.24 to 3734.26, 3745.01, 3746.04, 3746.10, and 3746.14 and to enact sections 5301.80 to 5301.92 of the Revised Code to establish environmental covenants as an interest in real property generally arising under an environmental remediation or mitigation project that imposes activity and use limitations on the property, to require the recording of such covenants, and to establish other requirements regarding environmental covenants.

H. B. No. 517-Representatives Kearns, Latta, McGregor, Wolpert.

To amend sections 2907.24, 2907.241, 2907.25, 2933.42, 2933.43, 4510.07, and 4510.13 of the Revised Code to increase the penalties for soliciting, prostitution, and loitering to engage in solicitation and allow for the criminal forfeiture of contraband used in the commission of soliciting, prostitution, and loitering to engage in solicitation.

Said bills were considered the first time.
