INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 518-Representative Hoops.

To amend sections 4561.17, 4561.18, and 4561.21 of the Revised Code to calculate the annual general aviation aircraft license tax on a per seat basis and to deposit the money into the renamed Airport Assistance Fund to be used for improvements to publicly owned airports.

H. B. No. 519-Representatives Barrett, Schmidt, Aslanides, Carmichael, Allen, Beatty, Fessler, Carano, Brown, Hollister, DeGeeter, Perry, Cirelli, Yates, Kearns, Taylor, Mason, Koziura, Chandler, Woodard, Price, Harwood, Key, Driehaus, Sykes, Strahorn, Ujvagi, S. Patton, Miller.

To amend sections 1751.62, 3923.52, and 3923.53 of the Revised Code to require certain insurance policies extend coverage to newer forms of screening for cervical cancer detection.

Said bills were considered the first time.
