**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 242**-Representatives Taylor, Grendell, McGregor, Niehaus, Husted, Boccieri, Willamowski, Clancy, Martin, Setzer, Williams, Blasdel, Kearns, Carano, C. Evans, Miller, Brinkman, Redfern, Widener, Latta, Reidelbach, Schmidt.

To amend sections 102.02 and 102.022 of the Revised Code to require certain state retirement system officials and employees to file financial disclosure statements with the Ohio Ethics Commission.

**H. B. No. 243**-Representatives Raussen, Buehrer, Hollister, Reidelbach, S. Patton, Barrett, McGregor, Kearns, Willamowski, Gibbs, Fessler.

To amend sections 3901.043, 3901.51, and 3905.24, to enact section 3905.421, and to repeal sections 3957.01, 3957.02, 3957.03, 3957.04, 3957.05, 3957.06, 3957.07, 3957.08, 3957.09, 3957.10, 3957.11, 3957.12, 3957.13, 3957.14, 3957.15, 3957.16, 3957.17, 3957.18, 3957.19, and 3957.99 of the Revised Code to regulate the sale of home service contracts as consumer transactions rather than as the sale of insurance.

Said bills were considered the first time.
