To amend section 955.14 of the Revised Code to authorize a board of county commissioners to exempt persons sixty-five years of age or older from an increase in dog license registration fees or to establish a lower increase in fees for those persons.

H. B. No. 274-Representative Kearns.

To enact section 5533.491 of the Revised Code to designate a portion of United States Route 68 in Clark County the "Ron Burton Highway."

H. J. R. No. 9-Representative Sferra.

Proposing to enact Section 3a of Article XII of the Constitution of the State of Ohio to require that increases in state taxes be approved by a two-thirds majority of the membership of each house of the General Assembly.
