INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 550-Representative Flowers.

To amend sections 5502.01, 5503.02, and 5503.34 and to enact sections 4921.29 and 4925.01 to 4925.09 of the Revised Code to require the inspection of intermodal transportation equipment in accordance with an intermodal equipment safety program established by the Public Utilities Commission and to restrict certain indemnification clauses in transportation contracts.

H. B. No. 551-Representatives Harwood, Distel, McGregor, S. Patton, Strahorn.

To amend section 6115.20 of the Revised Code to increase from \$10,000 to \$25,000 the maximum value of a contract for an improvement that may be entered into by a sanitary district without initiating competitive bidding.
