INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 294-Representatives Ujvagi, Perry, S. Patton, Carano, Key, Miller, Beatty, Boccieri.

To amend section 4513.03 of the Revised Code to require the headlights of a vehicle to be lighted when its windshield wipers are in use.

H. B. No. 295-Representative Book.

To amend sections 1343.03 and 2325.18 of the Revised Code to modify the period of limitations for revivor of judgments and to preclude the accrual of

interest from the date a judgment becomes dormant to the date the judgment is revived.

Said bills were considered the first time.

BILLS FOR THIRD CONSIDERATION

To amend section 3727.06 of the Revised Code to allow podiatrists to make independent hospital admissions, was taken up for consideration the third time.
