**INTRODUCTION OF BILLS**

To amend section 2921.13 and to enact sections 5110.01, 5110.02, 5110.04, 5110.05, 5110.06, 5110.07, 5110.10, 5110.11, 5110.12, 5110.13, 5110.14, 5110.15, 5110.16, 5110.20, 5110.21, 5110.22, 5110.23, 5110.25, 5110.26, 5110.27, 5110.28, 5110.29, 5110.32, 5110.33, 5110.35, 5110.351, 5110.352, 5110.36, 5110.37, 5110.38, 5110.39, 5110.45, 5110.46, 5110.47, 5110.48, 5110.49, 5110.50, 5110.55, 5110.56, and 5110.57 of the Revised Code to create the Ohio's Best Rx Program.

**H. B. No. 312**-Representatives Flowers, McGregor, Price, Collier, Ujvagi, Setzer.

To amend sections 4749.01, 4749.02, and 4749.99 and to enact sections 4749.21 to 4749.33 of the Revised Code to create the Commission on Electronic Security System Regulation in the Department of Commerce and to license electronic security system companies and their employees who perform electronic security system services, and to certify electronic security system training programs and their instructors.

**H. B. No. 313**-Representative DePiero.

To amend section 2905.05 of the Revised Code to increase the penalty for criminal child enticement.

**H. B. No. 314**-Representatives Peterson, Webster, Allen, Seitz, Bocchieri, Kearns, Carano, Hollister, Cirelli, DePiero, Miller, Perry, Price.

To enact sections 1751.69, 3923.34, and 3923.341 of the Revised Code to require certain health care policies, certificates, contracts, and agreements and public employee benefit plans to provide qualified benefits for polypeptide-based and amino-acid-based formulas.

**H. B. No. 315**-Representatives Webster, Blasdel, Calvert, Carmichael, Clancy, Collier, Daniels, DeWine, C. Evans, D. Evans, Fessler, Flowers, Gibbs, Grendell, Hollister, Jolivette, Kearns, Latta, Martin, Niehaus, T. Patton, Raga, Reinhard, Schaffer, Schlichter, Schneider, Seaver, Setzer, J. Stewart, Trakas, Wagner, White, Wilson, Wolpert, Young.

To amend sections 2903.06 and 2903.08 of the Revised Code to expand aggravated vehicular homicide and aggravated vehicular assault to prohibit a person from causing death or serious physical harm as proximate result of operating a vehicle at a time when the person's driver's or commercial driver's license or nonresident operating privilege is suspended or when the person has no valid license and being involved in an accident, and to provide a "no actual knowledge" affirmative defense to a charge under this prohibition based on an administrative suspension.

Said bills were considered the first time.
