# INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 316**-Representatives Wolpert, McGregor, Hughes, Reidelbach, Cirelli, Raussen, Kearns, Williams, Latta, Brinkman, Seitz, Willamowski, D. Evans.

To enact section 341.27 of the Revised Code to provide sheriffs, deputy sheriffs, and county correctional officers with qualified immunity from damages caused by outside work details consisting of prisoners imprisoned for nonviolent offenses who volunteer for the work detail.

# H. B. No. 317-Representative DeBose.

To amend section 5502.52 of the Revised Code to reduce the number of activation criteria that must be met in order to implement the statewide emergency alert program and require that the child that is the subject of the alert be under thirteen years of age.

**H. B. No. 318**-Representatives Seitz, Fessler, Distel, McGregor, Webster, Husted, Willamowski, Aslanides, Martin, Raussen, Carano, Reidelbach, DePiero, Calvert, Widener, Hoops, Gibbs, Young.

To amend section 2107.27 and to enact section 2107.24 of the Revised Code to provide a procedure for a probate court to treat a document as a will notwithstanding its noncompliance with the statutory formalities for executing wills.

**H. B. No. 319**-Representatives Raussen, Niehaus, Willamowski, Allen, Barrett, Schneider, Seitz, Webster, Young, Kearns, Clancy, McGregor.

To amend sections 5703.21 and 5747.08 of the Revised Code to authorize the Tax Commissioner to provide municipal income tax administrators with access to school district income tax records and returns.

**H. B. No. 320**-Representatives Jolivette, Webster, Cates, Jerse, Miller, Hartnett, Harwood, Strahorn.

To amend sections 1501.21, 1501.22, and 1521.99 and to enact section 1521.065 of the Revised Code to require owners of low-level dams to install warning signs and buoys on or near the dams.

Said bills were considered the first time.
