### INTRODUCTION OF BILLS

To amend section 2967.03 of the Revised Code to limit the consideration of criminal charges against a prisoner in determining whether to parole the prisoner, to require the Adult Parole Authority to recommend statutory parole standards to the General Assembly, and to require the appointment of a committee to recommend a bill on parole standards.

To amend sections 3937.18, 4501.01, 4503.01, 4503.04, 4503.182, 4503.21, 4503.22, 4503.30, 4503.31, 4504.01, 4507.01, 4507.05, 4507.23, 4507.24, 4509.01, 4510.34, 4511.01, 4511.521, 4513.03, 4513.20, and 4513.24 of the Revised Code to permit certain motorized scooters to be operated in the same manner and in the same locations as motorized bicycles.

**H. B. No. 334**-Representatives Harwood, Strahorn, S. Patton, Barrett, Redfern, Chandler, Skindell, Carano.

To enact section 5.091 of the Revised Code to adopt "Famous Ohioans" as the state verse.
