INTRODUCTION OF BILLS

To enact sections 2307.84 to 2307.90 and section 2307.901 of the Revised Code to establish minimum medical requirements for filing certain silica claims or mixed dust disease claims, to establish premises liability in relation to those claims, and to prescribe the requirements for shareholder liability for those claims under the doctrine of piercing the corporate veil.

To amend sections 924.01, 924.04, and 924.09 and to enact section 924.011 of the Revised Code to enable certain persons associated with the equine industry to establish an equine marketing program.

H. B. No. 344-Representatives Domenick, Seaver, Webster, Harwood.

To amend Sections 41, 41.05, and 90 of Am. Sub. H.B. 95 of the 125th General Assembly to decrease GRF appropriation item 506-321, Institution Education Services, in the Department of Rehabilitation and Corrections, and increase GRF appropriation items 200-431, School Improvement Initiatives,

and 200-513, Student Intervention Services, in the Department of Education.

In memory of Corwin M. Nixon.

WHEREAS, The members of the House of Representatives of the 125th General Assembly of Ohio were deeply saddened to learn of the death of Corwin M. Nixon and extend our heartfelt condolences to his family and friends; and

WHEREAS, Corwin Nixon left an indelible impression on the people whose lives he touched, and he will be remembered as a spirited individual who contributed immeasurably to the world around him. A Warren County Commissioner from 1948 to 1960, a member of the Ohio House of Representatives from 1962 to 1992, where he served as minority leader from 1979 to 1992, and the manager of Lebanon Raceway, he was also active with the U.S. and Miami Valley trotting associations and the American Horse Council Board of Trustees and was instrumental in establishing the College of Osteopathic Medicine at Ohio University. In addition, he was inducted into the Ohio State Fair Hall of Fame in 1980 and the Ohio Harness Racing Hall of Fame in 1986, and he will be remembered for his generosity, talents, and seemingly inexhaustible energy; and

WHEREAS, Corwin Nixon's regard for improving the quality of life in our society was clearly evident in his personal sacrifices of time and effort to family, friends, and community. Giving generously of his energy and abilities in all of his endeavors, he displayed exceptional concern and insight, and his absence will be keenly felt; and

WHEREAS, A loving husband to his wife, the late Eleanor, a devoted father to his two children, Keith and Karen, and the proud grandfather of many grandchildren and great-grandchildren, Corwin Nixon always used his talents to the benefit of others, and the warmth and understanding which he readily extended to those around him will stand as a testament to his personal character. Although the void which his death has created can never be filled, the legacy of care and commitment which he established will surely live on; therefore be it
