INTRODUCTION OF BILLS

To amend section 109.77 and to enact sections 109.745 and 109.746 of the Revised Code to require the Ohio Peace Officers Training Commission to establish guidelines regarding training of peace officers in the handling of missing children and guidelines for a child recovery plan, to require all law enforcement agencies in Ohio to adopt those training guidelines and establish guidelines consistent with the Commission's child recovery plan, to require

certain peace officers to have that training, to amend the version of section 109.77 of the Revised Code that is scheduled to take effect on January 1, 2004, to continue the provisions of this act on and after that effective date, and to declare an emergency.

H. B. No. 346-Representative Young.

To amend sections 5739.02, 5739.025, and 5739.10 of the Revised Code to repeal the temporary sales tax increase.

To amend section 2303.23 of the Revised Code to require clerks of courts of common pleas to provide the Department of Insurance and Supreme Court with certain information regarding tort actions and to create the Commission on Responsible Legal Reform.

To amend section 4709.13 and to enact sections 4709.051 and 4713.071 of the Revised Code to eliminate a felony conviction as grounds for taking adverse action relating to a barber license and to prohibit the Barber Board or the Cosmetology Board interpreting a felony conviction as grounds for taking an adverse action against a person regulated under the Barber Law or the Cosmetology Law.
