The House met pursuant to adjournment.

Pursuant to House Rule No. 21, the Clerk called the House to order.

Representative McGregor was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 355-Representatives Callender, McGregor, Hagan, Fessler, Kearns, Carano, Seitz, Setzer, Faber.

To amend sections 504.01 and 504.02 of the Revised Code to provide additional ways of determining or estimating the population of the unincorporated territory of a township for purposes of meeting the 15,000 population requirement for adopting a limited home rule government in certain manners.

H. B. No. 356-Representatives Widowfield, Williams, Trakas, Callender, Grendell, Wagner, Peterson, Seitz, Wilson, Sferra.

To amend sections 133.01, 133.06, 4505.06, 5739.01, 5739.02, 5739.021, 5739.023, 5739.025, 5739.026, 5739.027, 5739.03, 5739.031, 5739.033, 5739.04, 5739.05, 5739.10, 5739.12, 5739.13, 5739.16, 5739.17, 5739.21, 5739.212, 5739.34, 5739.99, 5740.01, 5741.02, 5741.021, 5741.022, 5741.023, 5741.03, 5741.04, 5741.05, 5741.06, 5741.08, 5741.11, 5741.12, 5741.15, 5741.16, 5741.19, 5741.21, and 5741.23 and to enact sections 133.061, 5739.41 and 5741.31 of the Revised Code to permit school districts in a county to impose, with voter approval, a sales and use tax in the county; and to amend the versions of sections 5741.021, 5741.022, and 5741.023 of the Revised Code that are scheduled to take effect January 1, 2006, to continue the provisions of this act on and after that date.

Representative G. Smith moved to amend the title as follows:

Representative G. Smith moved to amend as follows:

In line 21, after " jurisdiction " insert " .
A lien may be extended by the filing of an extension certificate that references the original certificate and any previous extension certificates prior to the expiration date of the original certificate or then current extension certificate, in which case the lien is valid for a period of five years from the date of the filing of the extension certificate unless sooner released or satisfied in the manner provided in this section. Any lien filed under this section. Any lien filed under this section prior to the effective date of this amendment shall be valid for a period of five years after the effective date of this amendment unless sooner released or satisfied in the manner provided in this section, and may be extended by the filing of an extension certificate prior to the expiration of the five-year period "

In line 22, strike through "certificate" and insert " certificates "

In line 4 of the title, after "filing" insert "a certificate or extension certificate with the county recorder"

The motion was agreed to and the bill so amended.
