## INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 357**-Representatives Jolivette, Cates, Webster, Husted, Collier, Schmidt, Schaffer, Widowfield, McGregor, Seaver.

To amend sections 145.43, 145.57, 148.10, 742.461, 2105.19, 2901.01, 2921.34, 2930.01, 2943.03, 2943.031, 2945.37, 2945.371, 2945.391, 2945.392, 2945.40, 2945.401, 2945.402, 2949.28, 2967.131, 2969.01, 2969.04, 3307.37, 3307.562, 3309.44, 3309.67, 5119.02, 5119.57, 5120.16, 5122.01, 5122.011, 5122.02, 5122.15, 5122.21, 5123.01, 5123.03, 5123.69, 5123.701, 5123.76, and 5505.26 and to amend and renumber as indicated in parentheses the version of section 5123.011 (5123.013) of the Revised Code as originally enacted by Am. Sub. S.B. 285 of the 121st General Assembly, to reclassify the plea of not guilty by reason of insanity as guilty but insane, and to require a trial court to impose a sentence of imprisonment upon a person found guilty but insane.

To amend section 3506.10 of the Revised Code to require a voting machine purchased, rented, or otherwise acquired or used in this state to produce a voter-verified paper record that must be used in any recount or manual audit conducted for an election in which that voting machine is used, and to require the Secretary of State or a board of elections to initially set any activation code required for the operation of a voting machine or the tallying of ballots on it.

**H. B. No. 359**-Representatives Ujvagi, Key, Allen, DeGeeter, Hartnett, Miller, Cirelli, Redfern, Seaver, Sferra, Woodard, Barrett, Harwood, Strahorn, Koziura, Skindell, Brown.

To amend section 3333.26 of the Revised Code to provide college tuition waivers to spouses and qualifying former spouses of members of the United States armed forces killed in the line of duty in a combat zone after May 7,

1975.

**H. B. No. 360**-Representatives Mason, DeGeeter, Hartnett, Seitz, Redfern, Otterman, McGregor, S. Smith, Ujvagi, Harwood.

To amend sections 2950.03, 2950.04, and 2950.041 of the Revised Code to include any person adjudicated a sexual predator within the reporting and notification requirements of the SORN Law.

Said bills were considered the first time.

The following joint resolution was introduced:

**H. J. R. No. 12**-Representatives Mason, Miller, Redfern, Sferra, S. Smith, Key, Ujvagi, Carano, Harwood, Strahorn, Seaver.

Proposing to amend Section 1 of Article V of the Constitution of the State of Ohio to eliminate the requirement that a person be registered to vote for thirty days in order to have the qualifications of an elector and be eligible to vote.

Said joint resolution was considered the first time.
