RESOLVED, That the House of Representatives and Senate hereby confirm the nomination of Bruce Johnson by the adoption of this resolution by a majority vote of the members elected to each house in accordance with Section 17a of Article III of the Constitution of the State of Ohio; and be it further

RESOLVED, That the Clerk of the House of Representatives and the Clerk of the Senate shall spread upon the pages of the Journal of each house this resolution and the vote of the members of that house voting on confirmation of that nomination.
