ONE HUNDRED THIRTY-THIRD DAY Hall of the House of Representatives, Columbus, Ohio Wednesday, January 25, 2006 at 12:00 o'clock p.m.

The hour having arrived for the meeting of the two houses in joint convention for the purpose of listening to the address of The Honorable Bob Taft, Governor of the State of Ohio, before the joint convention.

The members of the Senate preceded by the president, clerk and sergeant - at - arms thereof, appeared within the bar of the House.

The President of the Senate called the joint convention to order.

Representative Blasdel and Senator Jacobson announced a quorum of each house, respectively, was present.

The Governor's Color Guard, Colonel White High School Color Guard, presented the colors, followed by the Pledge of Allegiance to the Flag and the posting of the colors.

The Governor was escorted to the rostrum by the committee appointed where he addressed the joint convention.

On motion of Senator Jacobson, the joint convention was dissolved.

The House met pursuant to adjournment.

Prayer was offered by Father Mike Gribble of St. Joseph's Cathedral in Columbus, Ohio, followed by the Pledge of Allegiance to the Flag.

INTRODUCTION OF BILLS

To amend section 2744.03 and to enact section 3313.473 of the Revised Code to confer immunity from civil liability upon school districts, community schools, nonpublic schools, and school employees for an alleged injury to a student caused by school discipline, provided that such discipline does not result in student endangerment.
