The House met pursuant to adjournment.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 43-Representatives McGregor, Martin, Miller, S. Patton.

To enact sections 5111.86, 5111.861, and 5111.862 of the Revised Code to require the Department of Job and Family Services to seek a federal waiver to establish an assisted living Medicaid waiver component and to make an appropriation.

H. B. No. 44-Representatives S. Smith, Miller, Allen, S. Patton, Sykes, Ujvagi, Woodard, Barrett, Key, Strahorn, Brown, Beatty, Healy, Chandler, Skindell.

To amend section 3701.241 and to enact section 3701.2411 of the Revised Code to create the Minority HIV and AIDS Task Force, to require the Department of Health to develop and administer a statewide HIV and AIDS prevention campaign directed toward at-risk members of minority groups, and to make an appropriation.

H. B. No. 45-Representatives Webster, Calvert, McGregor, Setzer, Aslanides, Kearns, Woodard.

To amend section 3105.171 of the Revised Code to require parents in a proceeding for divorce, dissolution of marriage, legal separation, annulment, or allocation of parental rights and responsibilities to consider the cost of each child's postsecondary education.

H. B. No. 46-Representatives Schaffer, McGregor, Fessler, Taylor.

To amend section 5747.01 of the Revised Code to increase tax-deductibility of unreimbursed medical expenses and to expressly incorporate favorable tax treatment of new health savings accounts.

H. B. No. 47-Representatives Beatty, Core, Brinkman, Seitz, Miller, Key, Strahorn, Taylor, S. Patton, Skindell, Allen, DeGeeter, Koziura, Ujvagi, Barrett, Perry, Brown, Chandler, Healy, Hagan.

To amend section 3313.603 of the Revised Code to require that every high school include instruction in personal economics in the requirements for graduation.

H. B. No. 48-Representatives Hughes, Aslanides, Combs, C. Evans, D. Evans, Faber, Flowers, Gibbs, Hoops, Kearns, Latta, McGregor, Oelslager, Schaffer, J. Stewart, Taylor, Trakas, Webster, DeGeeter, Otterman, Perry.

To amend section 2913.49 and to enact section 109.94 of the Revised Code to increase the penalty for identity fraud against an elderly person or disabled adult, and to create the Identity Fraud Passport.

Said bills were considered the first time.
