INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 526-Representatives Fende, Skindell, Harwood, Brinkman, Ujvagi, Driehaus, Williams, Chandler, Yates.

To enact section 3506.24 of the Revised Code to require a county that uses direct recording electronic voting machines with a voter verified paper audit trail as its primary voting system to conduct a random recount of one county office, question, or issue voted on at a general election using that paper audit

trail.

H. B. No. 527-Representatives Uecker, Flowers, Trakas, McGregor, J., McGregor, R., Fende, Chandler, Perry.

To enact sections 4770.01 to 4770.12 of the Revised Code to require the licensure of security systems companies, to provide for the registration of individuals performing specified types of work related to security systems, to provide for the regulation of security systems companies and employees, and to establish the Security Systems Advisory Board in the Department of Public Safety.

Said bills were considered the first time.
