The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Peterson was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 141-Representatives Willamowski, Aslanides, Combs, McGregor, Seitz, Perry, Hartnett, Faber, Barrett, Taylor, Gilb, Hagan, Reidelbach.

To amend sections 149.43, 2921.24, 2921.25, and 4501.271 of the Revised Code to give parole officers, probation officers, and field officers the same options as peace officers with respect to confidentiality of certain personal information.

H. B. No. 142-Representatives Willamowski, C. Evans, McGregor, Seitz, Raga.

To enact section 5747.124 of the Revised Code to authorize the Tax Commissioner to collect from state income tax refunds certain debts owed to courts, counties, municipal corporations, and townships.

H. B. No. 143-Representatives Willamowski, White, Raussen, Combs, Fessler, Kearns, Martin, Peterson, Reidelbach, Schneider, Seaver, Webster, Widowfield, Barrett, Beatty, Harwood, C. Evans, McGregor, Seitz, Gilb, Hood, Flowers, Driehaus, Blasdel, Carmichael.

To enact section 4715.231 of the Revised Code to allow a dental hygienist under the supervision of a dentist to administer local anesthesia to a patient.

H. B. No. 144-Representative Buehrer.

To amend section 2317.02 of the Revised Code to waive the physician-patient and attorney-client privileges in probate cases under certain circumstances.

H. B. No. 145-Representatives Seaver, D. Evans, Reinhard, C. Evans, Setzer, Raga, Wolpert, Flowers, Reidelbach.

To amend sections 2935.01 and 2935.03 and to enact section 505.382 of the Revised Code to give townships authority to confer certain investigative and arrest powers upon officers in their fire departments.

H. B. No. 146-Representatives Harwood, Kearns, Carano, Seitz, Chandler, Hood, Brown, Williams, S. Patton.

To amend sections 4549.61, 4549.62, and 4549.63 of the Revised Code to modify the guidelines governing seizure of a motorcycle by a law enforcement officer when the identity of the motorcycle cannot be determined and to establish limited civil liability with certain exceptions if the law enforcement officer or agency fails to comply with specified guidelines.

H. B. No. 147-Representative Fessler.

To amend sections 1541.03, 1541.22, and 1547.75 of the Revised Code to prohibit the Division of Parks and Recreation in the Department of Natural Resources from adopting rules establishing a fee for parking a motor vehicle in a state park or for admission to a state park, to allow the Director of Natural Resources to transfer up to four million dollars from the Waterways Safety Fund to the State Park Fund, and to declare an emergency.

H. B. No. 148-Representatives Trakas, DeGeeter, McGregor, Buehrer, S. Patton, Otterman, Brown.

To enact sections 4722.01, 4722.02, 4722.021, 4722.03 to 4722.15, and 4722.99 of the Revised Code to adopt the Home Improvement Contractor Law, establish the Home Improvement Contractor Registration Board in the Department of Commerce, establish civil and criminal penalties for violation of the law, and grant the attorney general enforcement powers.

Said bills were considered the first time.

On motion of Representative McGregor, the House adjourned until Thursday, March 24, 2005 at 11:00 o'clock a.m.
