The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Coley was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 149-Representatives Calvert, Raga, McGregor, C. Evans, Latta, Aslanides, Hartnett, Chandler, Oelslager.

To amend sections 5733.98, 5747.08, and 5747.98 and to enact sections 149.307, 5703.75, 5733.47, and 5747.76 of the Revised Code to authorize a nonrefundable tax credit for rehabilitating a historic building.

H. B. No. 150-Representatives Gibbs, McGregor, Ujvagi, C. Evans, Kearns, Williams, Hagan, Reidelbach.

To amend section 4737.99 of the Revised Code to increase the penalty for violating the law governing junk yards and secondhand dealers.

H. B. No. 151-Representatives Calvert, McGregor, C. Evans, Wagner, Latta, Aslanides, Hartnett, Kearns, Buehrer.

To enact section 2921.29 of the Revised Code to require a person to provide certain personal information to a law enforcement officer when the law enforcement officer reasonably suspects the person is committing, has committed, or is about to commit a criminal offense.

H. B. No. 152-Representative Blessing.

To amend sections 5111.02 and 5112.17 of the Revised Code regarding Hospital Care Assurance Program (HCAP) services and Medicaid reimbursement for services rendered in a hospital emergency department or room.

H. B. No. 153-Representatives Mitchell, Perry, Allen, Beatty, Brown, S. Smith, Harwood, Ujvagi, Yates, Miller, Hartnett.

To amend section 5739.02 of the Revised Code to narrow the existing sales

tax exemption for motor vehicle purchases by nonresidents so that it applies only to residents of a state extending a similar exemption to Ohio residents.

H. B. No. 154-Representatives Harwood, Skindell, Carano, Miller, Chandler, S. Patton.

To establish a two-year moratorium on the issuance of licenses for new construction and demolition debris facilities and to require a study concerning the impacts of construction and demolition debris facilities.

H. B. No. 155-Representatives Seaver, Flowers, D. Evans, McGregor, Hoops, Willamowski, Combs, Perry, Kearns, Collier, C. Evans, Wolpert, Schaffer, Reidelbach.

To establish a legislative committee to study the feasibility and economic impact of school district consolidation.

Said bills were considered the first time.
