The journal of the previous legislative day was read and approved.

**INTRODUCTION OF BILLS**

The following bills were introduced:

**H. B. No. 158**-Representatives Seitz, Blasdel, Hartnett, Cassell, S. Patton, Harwood, D. Evans, Schneider, Webster, Brinkman, Driehaus.

To amend sections 3769.03, 3769.08, 3769.083, 3769.085, and 3769.088 and to enact sections 3769.0811, 3769.0812, and 3769.0813 of the Revised Code to authorize wagering at a track on horse races that are simulcast via an instant racing system and to levy a tax on amounts wagered in this manner.

**H. B. No. 159**-Representatives Mason, S. Smith, Miller, McGregor, Ujvagi, Willamowski, Koziura, Yuko, Sykes, Otterman, Hartnett, Brown, Skindell, Strahorn, Chandler, Perry, S. Patton, Oelslager, Key, Allen, Barrett.

To create the task force to study cancer death rates among African Americans in Ohio.

**H. B. No. 160**-Representatives Mason, S. Smith, Yuko, Sykes, Brown, Skindell, Chandler, Hood, S. Patton, Key, Allen, Barrett.

To amend sections 5733.98 and 5747.98 and to enact sections 5733.421 and 5747.391 of the Revised Code to create a tax credit for wages paid by employers to employees who have been convicted of felonies.

**H. B. No. 161**-Representatives Healy, Perry, Carano, C. Evans, McGregor.

To amend sections 2919.25, 3113.31, and 3113.33 of the Revised Code to modify the definition of "family or household member" for purposes of the criminal and civil domestic violence laws.

**H. B. No. 162**-Representative Peterson.

To amend sections 2152.20, 2301.51, 2301.52, 2301.55, 2301.56, 2301.57, 2929.01, 2929.34, 5120.031, 5120.111, 5120.112, and 5149.34, to enact new section 2301.58, and to repeal sections 2301.53, 2301.54, and 2301.58 of the Revised Code to revise the law governing community-based correctional facilities.

Said bills were considered the first time.

On motion of Representative Schaffer, the House adjourned until Tuesday, April 5, 2005 at 11:00 o'clock a.m.
