INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 563-Representatives Hoops, Setzer, Gilb, Evans, C., Collier, Fessler, Webster, Cassell, Hartnett, Yuko, Harwood, Carano.

To amend sections 1337.11, 2317.54, 5101.60, 5101.61, 5101.611, 5101.62 to 5101.64, 5101.66 to 5101.71, 5101.99, 5123.61, and 5126.31; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 5101.61 (5101.63), 5101.611 (5101.64), 5101.62 (5101.65), 5101.63 (5101.652), 5101.64 (5101.66), 5101.65 (5101.68), 5101.66 (5101.681), 5101.67 (5101.682), 5101.68 (5101.69), 5101.69 (5101.70), 5101.70 (5101.71), 5101.71 (5101.61), and 5101.72 (5101.611); and to enact new sections 5101.62 and 5101.67 and sections 5101.631, 5101.651, 5101.701, and 5101.702 of the Revised Code to revise the laws governing the provision of adult protective services.

H. B. No. 564-Representatives Schlichter, Combs, Evans, C., Wolpert, Webster.

To amend sections 955.12, 955.29, 955.32, 955.34, 955.35, 955.37, and 955.38; to amend, for the purpose of adopting a new section number as indicated in parentheses, section 955.34 (955.351); and to repeal sections 955.31 and 955.33 of the Revised Code to provide for the uniform determination of the fair market value of certain animals killed by a dog.

H. B. No. 565-Representative Setzer.

To amend sections 3301.42, 3313.603, 3313.61, 3313.615, 3314.012, 3314.03, 3325.08, and 3345.06 and to enact sections 3301.0713, 3302.032, 3313.6013, 3319.233, 3333.163, 3333.34, and 3345.061 of the Revised Code to establish the Ohio Core curriculum, to restructure admission requirements and remedial courses in state universities, and to implement other initiatives to enhance secondary and post-secondary education in Ohio.

Said bills were considered the first time.
