The House met pursuant to adjournment.

Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Brinkman was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 200-Representative Blessing.

To enact section 5733.08 of the Revised Code to impose a tax on the gross receipts of credit card companies for the purpose of funding state and local government and to credit the amount of such tax paid against any corporation franchise tax paid by the company.

H. B. No. 201-Representatives Seaver, Law, Latta, Gilb, Wolpert, Fessler.

To amend sections 2133.08, 2133.09, and 2133.15 of the Revised Code to give preference to the individual listed among those who may consent to withholding or withdrawing life-sustaining treatment who agrees in writing to not withhold or withdraw life-sustaining treatment from the patient and agrees in writing to incur all of the costs associated with the patient's medical care and life-sustaining treatment.

H. B. No. 202-Representatives Webster, J. Stewart, Martin, Fessler, Combs, Allen, C. Evans, DeGeeter, Reidelbach, Ujvagi, Setzer, Perry, Miller, Hagan, Brown.

To enact section 1349.19 of the Revised Code to authorize a payee of a check or draft to present a previously dishonored check or draft for payment by a financial institution as soon as the account drawn upon has sufficient funds and to prohibit a financial institution maintaining the account upon which a check or draft is drawn charging the payee any fee when the previously dishonored check or draft is presented for payment.

H. B. No. 203-Representatives Raga, Kearns, DeWine, Flowers, Wagoner, Calvert, T. Patton, Allen, Strahorn, Gilb, Chandler, Faber, White.

To amend sections 3707.26 and 4736.01 and to enact sections 117.102, 3313.473, 3314.12, and 3701.93 to 3701.98 of the Revised Code with respect

to inspections of public and nonpublic school buildings by boards of health, to require the Director of Health to establish the School Health and Safety Network to coordinate and collect data from school inspections, and to include Network inspection rules within the practice of environmental health for registered sanitarians.

H. B. No. 204-Representatives Latta, Trakas, McGregor, C. Evans, Gibbs, Wagoner, Allen, Fessler, Hartnett, Walcher, Chandler, Ujvagi, Law, D. Evans, Kearns, Williams, Seaver, Hughes, Aslanides, Harwood, Schaffer.

To enact section 4503.531 of the Revised Code to create "Operation Iraqi Freedom" license plates.

H. B. No. 205-Representatives Allen, Cassell, Distel, D. Evans, Fende, Fessler, Hartnett, Hood, Hughes, McGregor, S. Patton, Perry, Seaver, Yuko.

To amend sections 319.202, 323.152, 323.153, 323.154, 4503.06, 4503.064, 4503.065, 4503.066, and 4503.067 of the Revised Code to freeze the taxes on primary residences owned and occupied by persons 65 years of age or older.

H. B. No. 206-Representatives Martin, Gilb, Kilbane, Seitz, Daniels, Distel, Cassell, Collier, T. Patton, Brinkman.

To amend sections 317.08, 1501.01, 1504.02, 1506.01, 1506.02, 1506.06, 1506.08, 1506.10 to 1506.12, 1521.01, 1521.20, 1521.21, 1521.22, 1521.23, 1521.24, 1521.25, 1521.26, 1521.27, 1521.28, 1521.29, 1521.99, and 6121.04; to amend, for the purpose of adopting new section numbers as indicated in parentheses, sections 1521.20 (1506.38), 1521.21 (1506.39), 1521.22 (1506.40), 1521.23 (1506.41), 1521.24 (1506.42), 1521.25 (1506.43), 1521.26 (1506.44), 1521.27 (1506.45), 1521.28 (1506.46), 1521.29 (1506.47), and 1521.30 (1506.48); to enact section 1506.49; and to repeal section 1506.37 of the Revised Code to revise the law governing coastal management and the control of erosion along Lake Erie.
