INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 572-Representatives Healy, Williams, Yuko, Koziura, Otterman, Skindell, Carano, Harwood, Chandler.

To amend sections 3314.012 and 3314.03; to enact section 3314.18; and to repeal sections 3314.35 and 3314.36 of the Revised Code to require annual report cards for all community schools, to prohibit the payment of state funds to any community school that has been in a state of "academic emergency" or under "academic watch" for two consecutive years and fails to improve to "continuous improvement" or above by the next annual report card, and to repeal certain additional community school academic performance requirements.

H. B. No. 573-Representatives Healy, Williams, Woodard, Strahorn.

To enact section 3313.131 of the Revised Code to prohibit a member of a school district board of education from being an employee or governing board member of an operator or nonpublic sponsor of a community school or an employee or governing authority member of a community school that has a nonpublic sponsor.

H. B. No. 574-Representatives Dolan, Collier, Law, Martin, Distel, DeGeeter, Perry, Wagoner, McGregor, J., Yuko, Williams, Skindell, Seitz, Setzer, Flowers.

To enact sections 1522.01, 1522.02, and 1522.03 of the Revised Code to ratify the Great Lakes-St. Lawrence River Basin Water Resources Compact and to establish related requirements.

Said bills were considered the first time.
