INTRODUCTION OF BILLS

The following bills were introduced:

To amend sections 3743.06, 3743.19, 3743.60, 3743.61, 3791.031, and 5104.015 and to enact sections 307.205 and 505.83 of the Revised Code to permit counties and townships to regulate smoking in public places and places of employment.
