INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 318-Representatives Combs, Trakas, Reidelbach, Perry, McGregor, Fessler, Gibbs, Schaffer, Seaver, Buehrer, Willamowski, Taylor.

To amend sections 109.42, 2921.34, 2929.01, 2930.16, 2953.08, 2967.12, 2967.121, 2967.18, 2967.193, 2967.26, 2971.01, 2971.03, 2971.04, 2971.05, 2971.06, 2971.07, 5120.49, 5120.61, and 5149.10 of the Revised Code to require that, unless the offender is sentenced to death, every convicted offender who is sentenced as a sexually violent predator under the Sexually Violent Predator Sentencing Law be sentenced to a term of life imprisonment without parole.

H. B. No. 319-Representatives Trakas, Carano, Seaver, Setzer.

To amend section 3503.02 of the Revised Code to permit a person with multiple habitations to select one as the person's residence for the purpose of elections.

Said bills were considered the first time.

The following joint resolution was introduced:

H. J. R. No. 9-Representative DeWine.

Proposing to enact Section 16 of Article XI of the Constitution of the State of Ohio to limit to each year ending in the numeral one the time at which apportionment or redistricting of the state for General Assembly and congressional districts may be conducted, unless the currently applicable apportionment or redistricting plan is determined to be invalid by either the Supreme Court of Ohio or the Supreme Court of the United States.

Said joint resolution was considered the first time.
