Pursuant to House Rule No. 23, the Clerk called the House to order.

Representative Hagan was selected to preside under the Rule.

The journal of the previous legislative day was read and approved.

### INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 350-Representative Mitchell.

To enact section 3745.50 of the Revised Code to require the Director of Environmental Protection to adopt rules establishing standards and procedures for considering issues related to environmental justice when issuing permits or licenses and taking other actions under state environmental laws.

# H. B. No. 351-Representative Mitchell.

To enact section 3745.50 of the Revised Code to create the Environmental Justice Commission.

# H. B. No. 352-Representative Redfern.

To amend sections 4511.21 and 4511.251 of the Revised Code to establish a 35-mile per hour speed limit for highways outside municipal corporations within island jurisdictions.

## H. B. No. 353-Representative Redfern.

To amend section 3314.03 and to enact section 3313.621 of the Revised Code to prohibit public schools from opening for instruction prior to Labor Day except in specified circumstances.

# H. B. No. 354-Representatives T. Patton, McGregor, Reidelbach.

To amend sections 145.11, 742.11, 3307.15, 3309.15, 3334.11, 4123.44, and 5505.06 and to enact section 9.75 of the Revised Code to require any state agency with the authority to invest state funds to report on those investments using the global investment performance standards.

**H. B. No. 355**-Representatives Gilb, Bubp, Buehrer, Collier, Faber, Hood, Law, McGregor, Raga, Raussen, Schaffer, Setzer, Trakas, Uecker, White, Widener.

To amend section 3701.99 and to enact sections 131.51 and 3701.93 of the Revised Code to place ethical constraints on human research.

# H. B. No. 356-Representative J. Stewart.

To amend Section 206.66 of Am. Sub. H.B. 66 of the 126th General Assembly to require the Department of Job and Family Services to establish a TANF program that provides help to eligible households for home energy and weatherization costs during the winter of fiscal year 2006 and to make an appropriation.

### H. B. No. 357-Representative Uecker.

To enact section 5533.116 of the Revised Code to designate a portion of State Route 131 within Clermont County the "Sam Bateman Memorial Highway."

# H. B. No. 358-Representative Wagoner.

To amend section 5111.013 and to enact section 5111.0116 of the Revised Code to require Medicaid applicants to supply documentation of citizenship or alien status.

Said bills were considered the first time.
