### INTRODUCTION OF BILLS

The following bills were introduced:

**H. B. No. 430**-Representatives Bocchieri, Woodard, Carano, Yuko, DeGeeter, Garrison, Brown, Hood, Williams, Allen, Reidelbach, Harwood, Miller, Patton, S., Otterman, Barrett, Oelslager.

To amend section 5739.02 of the Revised Code to expand the sales and use tax exemption for sales of natural gas, and to extend a sales and use tax exemption to sales of propane used for home heating purposes.

**H. B. No. 431**-Representatives Peterson, McGregor, J., Ujvagi, Reidelbach, Schaffer, Flowers, Webster, Allen.

To amend sections 109.57, 109.572, 3317.022, 3317.029, 3317.0217, and 3317.03 and to enact sections 3310.51 to 3310.62 of the Revised Code to establish the Special Education Scholarship Program to provide scholarships for handicapped children to attend alternative public and nonpublic special education programs.

**H. B. No. 432**-Representatives Stewart, J., Reidelbach, Evans, C., Yuko, Chandler, Otterman, Garrison, Schaffer, Webster, Distel, Allen, Koziura, Perry.

To enact sections 3302.032 and 3317.60 of the Revised Code to establish a bipartisan committee to recommend to the General Assembly a system that provides state funds to pay one hundred per cent of the actual cost of providing a thorough and efficient education to each public school student and to require the Department of Education to report certain school funding information to the parents and taxpayers of each school district.

Said bills were considered the first time.
