The House met pursuant to adjournment.

The journal of the previous legislative day was read and approved.

INTRODUCTION OF BILLS

The following bills were introduced:

H. B. No. 433-Representatives Carano, Boccieri, McGregor, J., Yuko, Patton, S., Hartnett, Fende, Perry.

To amend sections 505.391, 505.82, 505.94, and 4513.10 of the Revised Code to provide urban townships with broader authority to regulate traffic, pedestrians, and obstructions during a declared emergency, to subject parked or stopped vehicles in urban townships to the same lighting provisions as specified for vehicles in municipal corporations, to allow urban townships to adopt a reasonable fee without a specified limit for transient vendor registrations, and to allow urban townships to charge for subsequent false fire alarms occurring any time after a notice of a previous false alarm is sent.

H. B. No. 434-Representatives Yuko, Otterman, Chandler, Allen, Cassell, Mitchell, Sayre, Miller, Brown, Ujvagi, Patton, S., Perry, Sykes, Smith, S..

To amend section 3701.99 and to enact sections 3701.94, 3701.941, 3701.942, and 3701.943 of the Revised Code to prohibit human cloning.

H. B. No. 435-Representative DeWine.

To enact section 3319.0811 of the Revised Code to require school districts to employ licensed athletic trainers under the same type of contract applicable to licensed occupational or physical therapists employed by the districts.

H. B. No. 436-Representatives Brown, Perry, Yuko, Patton, S., Otterman, Williams, Hartnett, Key, Barrett, Woodard, DeBose, Domenick, Mitchell, Strahorn, Evans, C., Boccieri, DeGeeter, McGregor, J., Reidelbach, Skindell, Ujvagi, Wagoner, Driehaus, Healy, Fende.

To amend sections 2152.02, 2152.10, 2152.12, 2919.25, 2919.251, 2919.26, 3113.31, and 3113.33 of the Revised Code to include children under the age of eighteen with whom an offender has had or has a dating relationship as victims under the domestic violence laws and to require mandatory transfer for criminal prosecution of a case involving a juvenile offender who is fourteen years of age or older, commits a homicide offense against such a child, and

previously committed domestic violence against that child.

Said bills were considered the first time.
