To amend sections 1333.84, 1333.85, 4301.13, and 4301.24 of the Revised Code to revise the statutes governing the termination of manufacturers'



franchise agreements with wine distributors, to eliminate the Liquor Control Commission's authority to set minimum mark-ups on wholesale wine sales and to fix minimum prices on wholesale wine sales, to prohibit volume and quantity discounting for the purpose of assisting the wholesale or retail sale of beer or intoxicating liquor, to allow wine distributors and wine retailers a maximum of thirty days of credit when purchasing wine, and to create the Wholesale Wine Distribution Study Committee.
