S. B. No. 110-Senators Fedor, Schuring, Roberts, Brady.

To amend sections 3314.012, 3314.013, 3314.015, 3314.02, 3314.03, and 3314.17 and to enact sections 3314.12, 3314.18, 3314.19, 3314.21, and 3314.22 of the Revised Code to revise the Community School Law, to place a two-year moratorium on the establishment of new community schools sponsored by entities other than the school districts in which they would be located, and to create the Joint Study Committee on Ohio's Community Schools.
