**S. B. No. 314**-Senators Kearney, Dann, Clancy, Zurz, Fingerhut, Roberts.

To amend sections 2152.17, 2152.72, 2929.14, and 5103.0319 and to enact section 2941.1417 of the Revised Code to require the imposition of a ten-year prison term upon a person who discharges a firearm while committing an offense and causes injury or death to a child.
